#### Notes on the 1974 Driving Tests by Rob Mouat:

William Jeanes wrote an article for the February, 1974 issue of <u>Car & Driver</u> titled "Armed and Dangerous," concerning various police departments in the U.S. and the inability of the officers to safely control their vehicles at speed.

Jeanes attended a seminar at the Orange County Speedway south of Los Angeles, where officers are taught safe driving at high speeds, and it is from his description of one of the training devices that I have adapted this year, for test number 6. It is a test in as much as it will determine if the contestant can adequately react to a simulated emergency situation within an established amount of time.

An interesting sidelight of this test is that you will be able to observe your reaction time to a stimulus. Average reaction time is 3/4 of one second. At 20 miles per hour you will be traveling at about 29 feet per second and therefore will have gone 21 feet before initiating action toward the right lane.

Think of this test as a lesson in thruway driving. We are using modest speeds but you can imagine driving at 80 mph at 117 feet per second! The secret to our particular test is to MAINTAIN 20 MILES PER HOUR -- any less and you will be penalized, and, any more, the test will be that much more difficult.

The depth perception test, number two, has also changed this year. I want you to imagine you are faced with a situation where you are forced to park quickly between two Rolls-Royces parked at a 45 degree angle to each other, with bumpers almost touching. A dark grey Pontiac is lurching toward you at an alarming rate of speed. How far and how fast can you get into that space?

We have tried to make the driving tests more fair to all participants and their cars this year, without actually handicapping the older cars. Please notice that we have de-emphasized speed in some tests and have altered the scoring in all tests, as well as introduced two new tests. It is hoped that the resulting larger scores will make for more equal competition.

#### water out the soul like of say the tree simi Report on Driving Tests by Activities Chairman, Robert Mouat, Jr.

Rolls-Royce weather and twenty-seven competitors ( more than ever before) contributed to what was really super Driving Test for 1974. For my part I was chagrined by my ignominious defeat by five other competitors and suffered a medium well roasting by the sun. This has, however, not blurred my enthusiasm for the meet, nor can it detract from the outstanding performances of everyone who took part in this event.

The tests themselves were, with one notable exception, very successful. I feel the results bore out my thought that a somewhat modified system of scoring would in effect smooth out the years as regards the older versus newer cars. Many factors entered in this evaluation and if we were not totally successful this year, we will be next year using our copious notes. This brings me to my next point -- the marshals - they were superb. Not only did they arrive on time; all performed their tasks cheerfully, accurately and professionally. Never have we finished the tests as early as we did this time. This is remarkable insofar as we had so many competitors than we have had before. Such efficiency can only be attributed to the marshals.

"At this point I should like to bring up a couple of points that were made by contestants. The first is the annual question of left hand drive versus right hand drive in the parking test. I feel that we are operating these cars primarily in the U.S. and that it is the efficiency with which we do this that we are testing in the Driving Tests. Anyway, counting all participants except the one with the highest (poorest) score the left hand drive cars (13 in all) had 875 points as opposed to the 695 points of the right hand drive cars (also 13). There may be a handicap hidden in these figures. However, I doubt it as in the depth perception test we kept accurate scores that cover distances to the sides of the cars. These figures bore no consistent correlation to the side of the steering column. All in all I do not think it is necessary to alter the format of the test anymore. As you are all aware there was a very generous time allowed for the parking -- 45 seconds. This was to take away the advantage previously held by the more modern cars. It never occurred to me that William Faircloth, Jr. could take 68 seconds to park his Silver Ghost (right hand drive). This is also the only test in which Joan Lueddeke did not finish in the top 10. Please do not take this as a snide remark since I could not be happier that Joan won. In fact I am not even that surprised as when I challenged at a meet earlier this year that I would win the test -- Joan was the only person who chortled. Congratulations Joan!!

"Apparently the new depth perception was really challenging -- more so than most people expected. To everyone -- except Joan -- she was first -- I guess that little car is a toy compared with a 'semi'. I am most certainly embarrassed to admit that in this, my own test, I was a total of 393 inches away from the line.

"Garaging went fairly well -- we only knocked down seven walls. The real winner in my book was the new reverse emergency stop where the poor dame was knocked down five times. Louise Keppler was visibly paled by her 'vehicular homicide' and complained that all the picnic goodies were falling off the seats; 'Yes, ma'am, tell it to the Judge'.

"In the wiggle woggle everyone did quite well. I didn't watch them all but I did see John Godfrey hit the first turn at about 40 mph, sideways. John finished the course at about 4.7 mph.

"After the wiggle woggle came the emergency reaction test. There was some argument about the clarity of my instructions and constructions. Some people claimed they could not see the lights and some people simply failed to read or later listen to the instructions. This latter complaint would not influence my decision on this test; however the former did. We have scrubbed the Emergency Reaction test for this year. Next year we will have superior equipment so there will be no excuses! Overall, the idea was well received and I think merits refinement.

"Once again our heartiest congratulations to Joan Lueddeke and her two followers: Dr. Robert Schoenberg, second, and Dr. Halsey Bullen, third. Actual awards will be made at the Fall Tour. After the tests we had the best social event I have attended at the gracious manor house of Hal and Madeline Porter. It was a glorious afternoon. Everyone had plenty to drink and eat -- the food supplies generously supplemented by the Cantero's six foot Submarine sandwich that I understand was manufactured by themselves. I was refreshed by Bill Lueddeke's Ripple (a sedentary little wine and was impressed by its presumptuousness). Rusty Ettinger did somewhat better with the tests than he did with his very complex kite -- am convinced it was made aerodynamically unstable by the some 18 pounds of cellutape glueing it together.

"Thank you all for making this a very enjoyable day for me -- and special thanks to the winners, the marshals and the Porters for their selfless contributions.

"The marshals were Bill Lueddeke, Joan and Geoffrey Dalton, Polly Bullen, Abby Mouat, Emily Walker, George Tolman, Ted Hoffman, Ed McLarens, Jr. and Sr., John Reichard, Marge Francis, Sandy Girvin, Jayne Hoffman, Eleanor McLaren, Patty and Jacquie Mintz, Graydon Walker, John Godfrey and Rob Mouat.

Wine Tasting Report: Virginia and Bud Korteweg were gracious hosts for this "Gatsby" event which was certainly the year's social event for New Jersey with more than fifty RR/Bs and more sheiks and shebas (lounge-lizards and flappers to you) than you could shake a cocktail shaker (bath-tub gin) at. The grounds were beautiful, the weather wonderful and we even had an animal-act with a high-diving dog. He made quite a splash.

Hope and Robert Fergusson worked like 1925 gangster racketeers collecting the money for wine and glasses, and sent out a map showing where you had to pay. Hope and Jacquie Mintz were hostesses which is no small job for such a mob.

Prizes were awarded by popular vote for the "best costumes" of the Gatsby era. Your chairman, had he been a judge, would have awarded first prize to the girl with the one true landmark of that time - stockings rolled below the knee. But there were none in sight - evidently, the fashions of the time were not what I lived through but what some Hollywood studio art director thought would photograph better fifty years later. First prize: Beth Gincher, six silver plated wine goblets. Second: Pat Veprovsky, wine assortment. Third: William Greenbaum, "Goldworm" Rolls-Royce dress (were there transvestites in the 'Twenties?). Fourth: Len Goldfarb, R-R letter opener.

Our wine expert was Albert L. Jacobs, Jr., Chevalier, Confrerie du Tastevin. His notes follow; memorize them and impress the next sommelier you meet:

"Four wines were selected for a comparative tasting: two whites and two reds.

"The white wines selected were Pouilly Fumé, Chateau de Nozet, 1971, and a Konstantin Frank, 1969, Pinot Chardonnay. The Pouilly Fumé is a dry white wine from the Loire Valley characterized by a freshness and slight acidity with a light flavor of cheese or truffles. This wine is produced from the Sauvignon vine which is used to produce sweet wines in the Bordeaux area. This wine is best at five years or younger, and preferably at two to three years of age.

"The Konstantin Frank Pinot Chardonnay is a dry white wine from Hammondsport, New York -- the Finger Lakes area. It is a white Burgundy-type produced from the Chardonnay grape. It is more robust than the Pouilly Fumé and longer-lived. Of particular interest is the lack of 'foxy' taste which normally characterizes New York State wines.

"The red wines selected were a Brouilly, Chateau de la Chaize, 1973, and a Charles Krug, 1970, Zinfandel. The Brouilly is a wine from the Beaujolais District in France

and is characterized by a light and fruity taste. It is light in color and is best at two to three years of age. Brouilly is one of the communes of Beaujolais and a wine marked 'Brouilly' as opposed to 'Beaujolais' is better assurance of uniformity and quality. This wine will not age and five years should be considered the outer drinking age.

"The Charles Krug Zinfandel is a California wine from the Napa Valley. It is a fruity wine of light to moderate body and has a pleasant balance between acidity and tannin. The Zinfandel grape is a hybrid unique to California. This particular Zinfandel would probably improve for over the next year or two but not much beyond that. Certain other Zinfandels such as the Martini Special Selection Zinfandels are capable of tremendous body and are especially longer-lived."

Report on Rally: This, starting at Caldor's in Greenwich, Conn., and ending with a picnic at Dr. Halsey Bullen's home, was one of our most interesting rallies, and certainly one of our finest picnics. All week, the weather looked worse than a Wail Street report, but Sunday turned out to be the most marvelous day of the summer. Gordon Barnes (CBS weatherman) from whom we have been taking our weather for years (we don't trust nuthin' that comes out of Washington these days!) outdid himself. I am appointing him an honorary member of the Rolls-Royce Atlantic Region, subject to impeachment if he backslides.

Ted Hoffman and Ed Eaton (these guys do a lot of work) started us off and Polly and Halsey Bullen checked us in. Remember, you had to pick up two nuts from buckets enroute? #### Burglar Alarms on Mascots

ROLLS-ROYCE is considering fitting burglar alarms to all "Flying Lady" radiator mascots because so many are being stolen for sale to collectors. They fetch between L30 and L50.

They are becoming increasingly popular among teenagers who fit them on to old bangers and families who use them as ornaments. New mascots are available only to owners of Rolls-Royce cars.

A sudden spate of thefts, estimated at about 20 a month throughout Britain, is causing Rolls-Royce mascot casting foundry in Crewe to fall short of demand.

Each stainless steel mascot has to be cast and nickel or chromium plated. Each takes a week to produce.

A spokesman for Rolls-Royce said last night: "The mascots are in short supply because we cannot keep pace with the standard of morality of people with bolt cutters.

"We are seriously considering fitting mascot alarms to every new car rather than just offer them as optional extras."

Previously, the mascot, a young woman with flying robes depicting "The Spirit of Ecstasy," could be unscrewed. Rolls-Royce owners would carry out a "removal ritual" every time they left their vehicles unattended.
